# THREE YEAR LIMITED WARRANTY POLICY



Aeroseal warrants that its duct sealant products installed by Aeroseal shall be of like grade and quality to and in accordance with Aeroseal's published Material Data Sheet. In addition, Aeroseal warrants to the property owner ("Owner") that the installation of Aeroseal sealant will be free of defects for a period of 3-years in commercial applications after the date of the sealing application.

Upon satisfactory demonstration by Owner that the foregoing warranty has been breached and that Owner is eligible for such warranty, Aeroseal will reimburse the Owner an amount equal to the direct documented costs to repair or replace the defective duct seals, including the direct labor costs of performing the repair or replacement, but not including general overhead, administrative costs, travel time or other general costs.

In order to make a claim, Owner shall submit to Aeroseal a warranty claim form and provide such other information regarding the defective duct seals as Aeroseal may reasonably request. At its discretion, Aeroseal LLC will either send the reimbursement within 30 days of accepting the completed claim or schedule a date to repair the product installation. Aeroseal, LLC also reserves the right to apply the claim amount to any outstanding and unpaid account balance.
